ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Maharishi Arvindo College of Education, Vill & PO- Ramayan, Tehsil- Hansi, District, Hisar, Haryana vide Order No. F. NRC/NCTE/F-7/HR-786/2007/20271-77 dated 29th September 2007 for B.Ed. Course of two years duration with an annual intake of two unit (s) of 50 students each followed by Revised Recognition order no. NRC/NCTE/HR-786/2015/98950-955 dated 14th May, 2015 for annual intake of two units of 50 students each.

AND, WHEREAS, the institution submitted an application received in the NRC office, on 15.06.2016 for Shifting of premises of the institution from VPO- Ramayan, Tehsil- Hansi, District- Hisar to VPO- Bhattu Mandi, Tehsil & District- Fatehabad, Haryana .

AND, WHEREAS, the matter was placed before the NRC in its 254th meeting held from 28th to 30th June, 2016 and the Committee decided to constitute VT for conducting inspection so as to ascertain the preparedness of the institution for shifting of its premises.

AND, WHEREAS, the VTR received in the NRC office on 11.05.2018 was considered by the NRC in its 287th meeting held from 18th to 20th July, 2018 and the Committee decided as under:-

- Shifting of the institution at new premises i.e. Khewat No. 68 Min, Khasra No. 118//16 Min, VPO- Bhattu Mandi, District Fatehabad, Haryana for running B.Ed. course is permitted.

AND, NOW, therefore, the Northern Regional Committee hereby grants permission to Maharishi Arvindo College of Education, to shift its premises from VPO- Ramayan, Tehsil- Hansi, District- Hisar, to Khewat No. 68 Min, Khasra No. 118//16 Min, VPO- Bhattu Mandi, District Fatehabad, Haryana under clause 8(9) of the NCTE Regulations, 2014 for running B.Ed. course with an annual intake of two unit (s) of 50 students each.
